The 2017 Shoot will have different categories of shooters with awards for each category champion: 1) Sponsors, 2) \$500 registered shooters, 3) seniors (age 65+), and 4) active and retired SF guys (yes, age 65+ guys can compete for more than one trophy).

The chapter needs members who can recruit one or more sponsors at \$1000, \$3000 or \$5000 each and for \$500 shooters. Event marketing material was emailed to all chapter members during April. Hard copy flyers will be provided during the May and June meetings for members to use to recruit shooters and sponsors.

- Ohio Military Hall of Fame. Jan Hauger, a chapter member, will investigate the financial needs of this organization and report during a following meeting.
