The TREASURER'S REPORT

Chadd Kuhn reported the Chapter's combined balance of general fund and family support fund (The Oho Green Beret Support Group) is \$68,727.72 as of 1 February including \$9756.74 in the Operations fund and \$58,970.98 in the Ohio Green Beret Support Group (family support fund). This total includes a \$1000 donation made by the chapter to The Ohio Military Hall of Fame for Valor.

-Meeting agenda was outlined by Mark Arnold. Discussion items follow:

NEW BUSINESS:

- 1. Jesse Boyd led the swearing in of Chapter Officers for the 2019-2021 term: Patrick Enlow, President, Mark Arnold, Vice President, Andy Schneider, Secretary.
- 2. American Legion Membership.
 - Member Rick LaValley recommends that chapter members join and become leaders at multiple American Legion posts. The IRS requires the American Legion to donate 25% of charitable collections to charitable organizations; The Ohio Green Beret Support Group qualifies. Again, SFA 45 members are encouraged to be active leaders at Legion posts so they can make credible arguments for Posts to donate annually/monthly to The Ohio Green Beret Support Group. Our scholarship program is attractive to the Legion and the IRS.
- 3. Meeting and luncheon at The National Veterans Museum, Columbus, OH **Andy Schneider** suggested we hold an upcoming meeting there. He will reach out to the Museum's management to discuss a date, venue, food and entrance fee waiver.
- 4. Green Beret for a Day.

Following discussion on this potential fund raising initiative, **Andy Schneider** drafted an activities program for civilians to donate and participate in this. Shooting, SF skills events, gear and training demonstrations by B/2/19 SFG, and possible viewing an airborne operation are part of this. This concept is based on successful program the Legion Foundation has done in coordination with 5th SFG for fundraising. More discussion with the Ohio National Guard continues.

Mark Arnold briefed that this event is in jeopardy of not happening in 2019. The Match Director from Pickaway County Sportsmen, Inc. is unavailable to manage this for 2019. Another potential Director is being sought within PCSI.


Lunch cost at AMVETS 89 is paid by the chapter, and the Post committed to preparing and serving this for us monthly.

11. CHAPTER FUNDRAISING.

Tom McGrath is preparing a second filing with the IRS to establish The Ohio Green Beret Support Group, LLC. This is a 501(c)(3) Charitable subsidiary organization to Chapter 45. Tom's application has not received final approval from the Ohio Department of Taxation. This has proven a barrier to even gaining donations from organizations who have committed them to us. The project requires completion.

Its Federal Tax Identification number is: 83-1512941.

We will include this number in receipts to donors to the chapter. Donations should be made payable to **The Ohio Green Beret Support Group, LLC**. All donations to this are entirely tax deductible.

Fund-raising purposes.

Funds will be used to support chapter members, members of B/2/19, and other Green Berets who call Ohio their home to support their family when specific circumstances inhibit Green Berets from supporting their family alone.

12. SCHOLARSHIP PROGRAM.

This is our primary program for our fund raising. It will be two to four annual \$1000 grants of tuition assistance for chapter members and their immediate family. Definition follows: Chapter member, spouse, or direct lineal descendent of the chapter member; or be a legally adopted dependent or acknowledged by The Defense Enrollment Eligibility Reporting System (DEERS) as a dependent of the chapter member. Tuition grant programs are normally for a four-year degree, but the chapter voted unanimously that the program may include tuition assistance for private or public learning institutions other than a university and other than a bachelors degree; this includes vocational training. Chadd Kuhn suggested we support the same educational categories covered by the GI Bill. Mark Arnold, Ed Wheeler and Tom McGrath will be the Committee, and Mark will recruit a fourth person and probably a fifth (non-chapter members) for the Committee; having an executive non-member is a practice recommended by the IRS for non-profit Boards. Mark Arnold will recruit one or two central Ohio based professional/executive for our Board.

13. SFA 45 will support an SF Gold Star Family.

The family of SFC Dan Crabtree, KIA Iraq 2005 is our family for the SFA Convention 2019. **Kevin Colwell** volunteered to be the action officer for this initiative.
