NEW BUSINESS:

Open Action Items:

- 1. Mail Chip: **Patrick Enlow** has opened a Mail Chimp account for Chapter 45. He has imported email addresses into the account. Once the email lists are cleaned up and testing has occurred watch for future meeting minutes to arrive through Mail Chimp. **Patrick** will link one of the new debit cards to this account.
- 2. Sponsor Drive: **Eric Stansifer** suggested and volunteered to develop a concept for a fundraising event that includes a celebrity guest speaker. These are complex events and would be a large step for the Ohio Green Beret Support Group. This would be an event similar to what The Green Beret Foundation has done in the Cincinnati area.
- 3. **Tom McGrath** and Philip Taraska reported in January that the chapter has been charged with a \$4600 invoice from the project manager of the Crabtree Memorial Monument. Once again Tom reported that there has been no response from the plaintiff regarding a letter Tom mailed to him rejecting the claim.
- 4. **Chadd Kuhn** will establish a new PO Box for the chapter.

It is at a convenient location: At the exit of I-270 North and Cleveland Ave.


