SUBJECT: Meeting Minutes 8 September 2016 and Committee Meetings September

The TREASURER'S REPORT was provided by Roger Hobson and Chadd Kuhn. Balance as of 1 September was \$11,604 plus \$5383.41 in the Family Support Fund. Combined fund raising for the Golf Scramble, 3 Gun Shoot and Motorcycle Run netted over \$23,000 profits.

7. EVENTS.

a. 3 Gun Shoot.

Mark Scott did a great job of coordinating and leading this event with Pickaway County Sportsmen Club, Inc. on 10 SEP. Butch Betzko and several other chapter members dedicated two days of their time to prepare for it and support it during the Shoot. Jason Conrad, a Director for PCSI, was the Club's liaison and event manager; we made Jason an Honorary Chapter member. Volunteer, John Souza, (professional chef) coordinated and prepared the afternoon meal and we made John an Honorary Chapter member. PCSI voted unanimously during their membership meeting to host us again next year. Mark Scott will lead the 2017 Shoot planning meeting during October. He also conducted two AARs following the event, so this huge success will be an even better Shoot next year.

- Over 120 people attended over half were B/2/19 members and their families.
- 78 Shooters participated; some competed, others shot one or more lanes without competing; some were family and spouses coached by GBs.
- The Shoot champion was B/2/19's SSG Lawrence Gattozzi.
- b. Motorcycle Blackjack Run and meal. Several chapter members supported this event to get it started on 1 OCT. Over 60 participants and 51 riders registered; all were military-supporting great Americans. Six members of SFMC Colorado Chapter (10th SF Group guys) rode three days out and back to participate and support the Ride. Chuck Ward did a great job of selecting, reconning, and leading a route; he also did a nice job of helping riders solve mechanical problems.

AAR items:

- 1) Planning for the event began way too late (first week of August). Several other charity rides in central Ohio were already on riders' schedules for 1 OCT well before we began communicating this event. The short time period also left some of the many moving parts of this event go unnoticed, not considered, or simply not completed.
- 2) Ride time was too early. 0800 registration and 0900 kickstands up time were too early for most civilians on a Saturday morning, and this discouraged available riders from participating. Begin registration at 1030 hrs with kickstands up at noon to 1300 hrs is recommended. Have a meal and entertainment at the end of the ride with zero stops or only one stop is best and less complicated.
- 3) Communication of the event to Ohio area motorcycle riders was not coordinated and tracked well. We need one person to lead a team of chapter members to get the word out digitally and at popular motorcycle venues and

track who and where the communication is made to in order to assure thorough communication.

- 4) Run event patches need to be fabricated for Riders.
- 5) Run "tags" (small colored zip tie or something like it) should be attached to registered riders' jackets to identify them as registered.
- 6) Registration cost should be \$20, not \$15.
- 7) An end of Run event (other than just a meal) at the finish point will make the Run more attractive to and memorable for riders.
- c. <u>Circleville Pumpkin Festival</u>. **Carl Fuller** is coordinating our chapter's participation in this high-visibility venue, **Saturday 22 October 2000 hrs**. Plan to arrive and park your vehicle early. It's best to park on the west side of downtown near Route 23 and Route 22 intersection; there is a grain elevator company in that vicinity and parking is available there (south of Main Street across street from Hardee's). This is a VERY well attended parade, and we'll have a lot of fun. You should consider arriving early and visiting the Pumpkin Show before the evening parade. Our rally point is on Main Street at the military vehicles we will ride in at 1930 hrs. B/2/19 will support this with two RAZRs and an LMTV. Our chapter members will ride in style. Wear some SF type T shirt, polo shirt, jacket, or blazer, and, of course, your beret. Questions? Call Carl Fuller at 740-601-2259.
- d. <u>Columbus Veterans Day Parade</u>. Parade is Thursday 10 November. **Tom McGrath** is leading this initiative; we will be supported by two SF RAZRs and one LMTV. Plan to arrive around 1030 hrs and park in a downtown surface lot or parking garage. Parade begins at 1200 hrs. Our rally point is TBD at this time, but will be in the vicinity of Nationwide Blvd and Neil Ave intersection (you'll see our military vehicles on Nationwide Blvd). Wear some type SF apparel or uniform. SFA Blazer is or jacket is recommended; beret required.
- e. Winter Fete 2016. 7 January 2017 downtown Columbus Renaissance Hotel. The Chapter voted to support B/2/19's Winter Fete with contributions and 20 dinner reservations are being held for chapter members. This is a spouse and significant other-friendly event.
